Any person who is entitled to object and who wishes to object to the granting of the application may, not later than 15 working days after the first publication of notice of the application on the Christchurch Alcohol Licensing Public Notice website (www.ccc.govt.nz/alcohol) (Being.....), file a notice in writing of the objection with the secretary of the Christchurch District Licensing Committee, PO Box 73013, Christchurch 8154.

Instructions – Display of notice on the premises

This Front Door public notice **MUST** be displayed in the main front entrance of the premises, so it can be viewed from outside the premises.

Please display immediately AND at the bottom of the sign **complete the date of the first publishing of the notification in on the Alcohol Licensing Website.**

The front door notice **MUST** be affixed within 10 working days after you have filled the application.

This notice **MUST** remain displayed for at least 10 days and ideally we encourage you to display it until the end of the 15 working day public notification period.

Renewal application – Confirmation of Publication of Notice

Within 10 working days after filing an application to renew an alcohol licence with the Christchurch District Licensing Committee, the applicant is required to publicly notify the application.

This notice must be published on the Christchurch Alcohol Licensing website.

We have completed this for you. **Your notice was published on 7 April 2021** and will remain displayed for at least 15 working days.

Please find attached a print out of the publication.

It is **your responsibility** to check the details published as detailed below the dotted line are correct and to immediately advise the Alcohol Licensing Team to discuss if a correction is required, ph 941 8999.

You must also have the separate Front Door notice displayed **immediately** until the end of the public notification period, and have completed on that Front Door notice the date of first publication (as above).
